<i>Keller</i>	[<i>as though throwing his whole nature open before CHRIS</i>]: How could I kill anybody?

<i>Keller</i>	[<i>trying to hush him</i>]: I didn't kill anybody!

- Antonio:* Is that anything now?
- Bassanio:* Gratiano speaks an infinite deal of nothing, more than any man in all Venice. His reasons are as two grains of wheat hid in two bushels of chaff: you shall seek all day ere you find them, and when you have them they are not worth the search. 5
- Antonio:* Well; tell me now what lady is the same
To whom you swore a secret pilgrimage,
That you to-day promis'd to tell me of?
- Bassanio:* 'Tis not unknown to you, Antonio, 10
How much I have disabled mine estate
By something showing a more swelling port
Than my faint means would grant continuance;
Nor do I now make moan to be abridg'd
From such a noble rate; but my chief care 15
Is to come fairly off from the great debts
Wherein my time, something too prodigal,
Hath left me gag'd. To you, Antonio,
I owe the most, in money and in love; 20
And from your love I have a warranty
To unburden all my plots and purposes
How to get clear of all the debts I owe.
- Antonio:* I pray you, good Bassanio, let me know it;
And if it stand, as you yourself still do,

- Bassanio:* In my school-days, when I had lost one shaft,
I shot his fellow of the self-same flight

Because what follows is pure innocence.
I owe you much; and, like a wilful youth,
That which I owe is lost; but if you please 35
To shoot another arrow that self way

As I will watch the aim, or to find both,
Or bring your latter hazard back again
And thankfully rest debtor for the first. 40
- Antonio:* You know me well, and herein spend but time
To wind about my love with circumstance;
And out of doubt you do me now more wrong
In making question of my uttermost
Than if you had made waste of all I have. 45
Then do but say to me what I should do
That in your knowledge may by me be done,
And I am prest unto it; therefore, speak.

- Bassanio:* In Belmont is a lady richly left,
 And she is fair and, fairer than that word, 50
 Of wondrous virtues. Sometimes from her eyes
 I did receive fair speechless messages.
 Her name is Portia – nothing undervalu'd
 To Cato's daughter, Brutus' Portia.
 Nor is the wide world ignorant of her worth; 55
 For the four winds blow in from every coast
 Renowned suitors, and her sunny locks
 Hang on her temples like a golden fleece,
 Which makes her seat of Belmont Colchos' strond,
 And many Jasons come in quest of her. 60
 O my Antonio, had I but the means
 To hold a rival place with one of them,
 I have a mind presages me such thrift
 That I should questionless be fortunate.
- Antonio:* Thou know'st that all my fortunes are at sea; 65
 Neither have I money nor commodity
 To raise a present sum; therefore go forth,

<i>Oberon:</i>	I wonder if Titania be awak'd; Then, what it was that next came in her eye, Which she must dote on in extremity. <i>Enter PUCK.</i> Here comes my messenger. How now, mad spirit! What night-rule now about this haunted grove?	5
<i>Puck:</i>	My mistress with a monster is in love. Near to her close and consecrated bower, While she was in her dull and sleeping hour, A crew of patches, rude mechanicals, That work for bread upon Athenian stalls, Were met together to rehearse a play Intended for great Theseus' nuptial day. The shallowest thickskin of that barren sort, Who Pyramus presented, in their sport Forsook his scene and ent'red in a brake; When I did him at this advantage take, An ass's nolle I fixed on his head. Anon his Thisby must be answered, And forth my mimic comes. When they him spy, As wild geese that the creeping fowler eye, Or russet-pated choughs, many in sort, Rising and cawing at the gun's report, Sever themselves and madly sweep the sky, So at his sight away his fellows fly; And at our stamp here, o'er and o'er one falls; He murder cries, and help from Athens calls. Their sense thus weak, lost with their fears thus strong, Made senseless things begin to do them wrong, For briers and thorns at their apparel snatch; Some sleeves, some hats, from yielders all things catch. <i>Oberon:</i>	This falls out better than I could devise. But hast thou yet latch'd the Athenian's eyes With the love-juice, as I did bid thee do?	
<i>Puck:</i>	I took him sleeping – that is finish'd too – And the Athenian woman by his side; That, when he wak'd, of force she must be ey'd. <i>Enter DEMETRIUS and HERMIA.</i>	40
<i>Oberon:</i>	Stand close; this is the same Athenian.	
<i>Puck:</i>	This is the woman, but not this the man.	
<i>Demetrius:</i>	O, why rebuke you him that loves you so? Lay breath so bitter on your bitter foe.	45

- Hermia:* Now I but chide, but I should use thee worse,
For thou, I fear, hast given me cause to curse.

<i>Prospero:</i>	For this, be sure, to-night thou shalt have cramps, Side-stitches that shall pen thy breath up; urchins Shall, for that vast of night that they may work, All exercise on thee; thou shalt be pinch'd As thick as honeycomb, each pinch more stinging Than bees that made 'em.	10
<i>Caliban:</i>	I must eat my dinner. This island's mine, by Sycorax my mother, Which thou tak'st from me. <i>Miranda:</i>	Abhorred slave, Which any print of goodness wilt not take, Being capable of all ill! I pitied thee, Took pains to make thee speak, taught thee each hour One thing or other. When thou didst not, savage, Know thine own meaning, but wouldst gabble like A thing most brutish, I endow'd thy purposes With words that made them known. But thy vile race,	40 45

- Though thou didst learn, had that in't which
 good natures
 Could not abide to be with; therefore wast thou 50
 Deservedly confin'd into this rock, who hadst

- Caliban:* You taught me language, and my profit on't

 Fetch us in fuel. And be quick, thou'rt best,
 To answer other business. Shrug'st thou, malice?
 If thou neglect'st, or dost unwillingly

OSCAR WILDE: *The Importance of Being Earnest*

11 Read this passage, and then answer the question that follows it:

- Gwendolen:* Ah! that accounts for it. And now that I think of it I have never heard any man mention his brother. The subject seems distasteful to most men. Cecily, you have lifted a load from my mind. I was growing almost anxious. It would have been terrible if any cloud had come across a friendship like ours, would it not? Of course you are quite, quite sure that it is not Mr Ernest Worthing who is your guardian? 5
- Cecily:* Quite sure. [*A pause.*] In fact, I am going to be his.
- Gwendolen* [*inquiringly*]: I beg your pardon?
- Cecily* [*rather shy and confidingly*]: Dearest Gwendolen, there is no reason why I should make a secret of it to you. Our little county newspaper is sure to chronicle the fact next week. Mr Ernest Worthing and I are engaged to be married. 10
- Gwendolen* [*quite politely, rising*]: My darling Cecily, I think there must be some slight error. Mr Ernest Worthing is engaged to me. The announcement will appear in the *Morning Post* on Saturday at the latest. 15
- Cecily* [*very politely, rising*]: I am afraid you must be under some misconception. Ernest proposed to me exactly ten minutes ago. [*Shows diary.*] 20
- Gwendolen* [*examines diary through her lorgnette carefully*]: It is very curious, for he asked me to be his wife yesterday afternoon at 5.30. If you would care to verify the incident, pray do so. [*Produces diary of her own.*] I never travel without my diary. One should always have something sensational to read in the train. I am so sorry, dear Cecily, if it is any disappointment to you, but I am afraid I have the prior claim. 25
- Cecily:* It would distress me more than I can tell you, dear Gwendolen, if it caused you any mental or physical anguish, but I feel bound to point out that since Ernest proposed to you he clearly has changed his mind. 30
- Gwendolen* [*meditatively*]: If the poor fellow has been entrapped into any foolish promise I shall consider it my duty to rescue him at once, and with a firm hand.
- Cecily* [*thoughtfully and sadly*]: Whatever unfortunate entanglement my dear boy may have got into, I will never reproach him with it after we are married. 35
- Gwendolen:* Do you allude to me, Miss Cardew, as an entanglement? You are presumptuous. On an occasion of this kind it becomes more than a moral duty to speak one's mind. It becomes a pleasure. 40
- Cecily:* Do you suggest, Miss Fairfax, that I entrapped Ernest into an engagement? How dare you? This is no time for wearing the shallow mask of manners. When I see a spade I call it a spade. 45

- Gwendolen* [*satirically*]: I am glad to say that I have never seen a spade. It is obvious that our social spheres have been widely different.
- [*Enter MERRIMAN, followed by the footman. He carries a salver, table cloth, and plate stand. CECILY is about to retort. The presence of the servants exercises a restraining influence, under which both girls chafe.*] 50
- Merriman*: Shall I lay tea here as usual, Miss?
- Cecily* [*sternly, in a calm voice*]: Yes, as usual. [*MERRIMAN begins to clear table and lay cloth. A long pause. CECILY and GWENDOLEN glare at each other.*] 55
- Gwendolen*: Are there many interesting walks in the vicinity, Miss Cardew?
- Cecily*: Oh! yes! a great many. From the top of one of the hills quite close one can see five counties.
- Gwendolen*: Five counties! I don't think I should like that; I hate crowds. 60
- Cecily*: [*sweetly*]: I suppose that is why you live in town? [*GWENDOLEN bites her lip, and beats her foot nervously with her parasol.*]
- Gwendolen* [*looking around*]: Quite a well-kept garden this is, Miss Cardew.
- Cecily*: So glad you like it, Miss Fairfax. 65
- Gwendolen*: I had no idea there were any flowers in the country.
- Cecily*: Oh, flowers are as common here, Miss Fairfax, as people are in London.
- Gwendolen*: Personally I cannot understand how anybody manages to exist in the country, if anybody who is anybody does. The country always bores me to death. 70
- Cecily*: Ah! This is what the newspapers call agricultural depression, is it not? I believe the aristocracy are suffering very much from it just at present. It is almost an epidemic amongst them, I have been told. May I offer you some tea, Miss Fairfax? 75
- Gwendolen* [*with elaborate politeness*]: Thank you. [*Aside.*] Detestable girl! But I require tea!
- [*from Act 2*]

How does Wilde make this conversation between Gwendolen and Cecily so entertaining at this moment in the play?
