## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

	supply of hot water at approximately 80 °C Candidates will raise their hand when they are ready for the hot water.	approximately 150 cm <sup>3</sup>

	dropping pipettes that can measure a 2 cm <sup>3</sup> volume	2
	25 cm <sup>3</sup> or 50 cm <sup>3</sup> measuring cylinder	1

**Question 2**

Each candidate should be provided with:

hazard	materials and apparatus	quantity per candidate
	30 cm ruler with a mm scale	1

**Preparation of materials***cooked white rice*

Any variety of cooked white rice that has a medium to high starch content is suitable. Low starch varieties such as basmati, wild or wholegrain rice are not suitable. Do not rinse the rice before or after cooking and allow the cooked rice to cool before presenting it to candidates in large test-tubes.

The test-tubes of cooked white rice can be prepared the day before the exam but should be stored in a cool place. Allow the rice to reach room temperature on the day of the exam.

*1% amylase solution* [MH] [HH] [C]

Dissolve 1 g of powdered amylase or mix 1 cm<sup>3</sup> of liquid amylase in 80 cm<sup>3</sup> of distilled water. Add more distilled water to make up to a total volume of 100 cm<sup>3</sup>.

*Benedict's solution* [MH]

A commercially prepared solution suitable for food testing will be adequate.
