## Instructions for preparing apparatus

These instructions detail the apparatus, reagents and specimens required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the teacher to test the apparatus appropriately. **No access is permitted to the question paper in advance of the examination session.**

It is assumed that the ordinary apparatus of a science laboratory will be available, including a supply of purified water (distilled or deionised).

If arrangements are made for different sessions for different groups of candidates, care must be taken to ensure that the different groups of candidates are effectively isolated so that **no information passes between them.**

**All specimens should carry only the code letters and numbers as indicated and their identity should not be revealed to the candidates.**

Supervisors should ensure that all specimens have the correct identity attached to the specimen and that these are **not** removed during the examination.

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Only those tests described in the Question Paper should be attempted. Pipette fillers and safety goggles should be used where necessary.

In accordance with COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant.

**C** = corrosive

**MH** = moderate hazard

**HH** = health hazard

**T** = acutely toxic

**F** = flammable

**O** = oxidising

**N** = hazardous to the aquatic environment

The attention of Centres is drawn to any local regulations relating to safety, first-aid and disposal of chemicals.

'Hazard Data Sheets', relating to materials used in this examination, should be available from your chemical supplier.

**For Question 1**

Each candidate will require

- (i) petri dish, labelled A, containing two large insect-pollinated flowers of the same species. The flowers should have both male and female parts (suitable examples are tulip or lily)
- (ii) mounted razor blade or scalpel
- (iii) white tile
- (iv) tweezers
- (v) mounted needle
- (vi) hand lens

**For Question 2**

No apparatus is required for this question.

**For Question 3**

Each candidate will require

- (i) 50 cm<sup>3</sup> solution labelled **A** which is 2.1 g potassium iodate(V), KIO<sub>3</sub> and 20 cm<sup>3</sup> 1.0 mol dm<sup>-3</sup> sulfuric acid made up to 1 dm<sup>3</sup> solution (**this solution should be made within 3 days of the examination**)
- (ii) 40 cm<sup>3</sup> solution labelled **B** which is 1.0 g sodium metabisulfite, Na<sub>2</sub>S<sub>2</sub>O<sub>5</sub> and 20 cm<sup>3</sup> 1.0 mol dm<sup>-3</sup> sulfuric acid made up to 1 dm<sup>3</sup> solution (**this solution should be made up immediately before the examination**)
- (iii) 40 cm<sup>3</sup> 5% starch solution labelled **starch**
- (iv) 50 cm<sup>3</sup> deionised or distilled water
- (v) 10 cm<sup>3</sup> measuring cylinder labelled **A**
- (vi) 10 cm<sup>3</sup> measuring cylinder labelled **B** (a 25 cm<sup>3</sup> measuring cylinder would be acceptable for **B**)
- (vii) test-tube (125 mm × 15 mm) with a mark showing the level for 5 cm<sup>3</sup> and a means to support it
- (viii) 100 cm<sup>3</sup> conical flask
- (ix) stopwatch

**For Question 4**

Each candidate will require

- (i) metre rule with a millimetre scale
- (ii) pivot – a prism or triangular wooden block marked **P** placed on the bench
- (iii) 50g mass secured to the rule, with its centre above the 5.0cm mark of the rule. The value of the mass must be hidden from the candidates. This mass should be labelled **M**
- (iv) selection of 10 × 10g slotted masses, so that candidates can use combinations of these to make up masses of 60g, 70g, 80g, 90g and 100g which will be placed on the rule

**Information required from the Supervisor**

The Supervisor is asked to carry out the experiments and to enter the results on a spare copy of the examination paper, clearly marked '**Supervisor's Results**' and showing the Centre number. This should be returned with the scripts. Failure to do so may cause the candidates to be penalised.

Spare materials and equipment should be available and can be provided without penalty. **Candidates should be made aware of this.**

**This form must be completed and returned in the envelope with the scripts together with the seating plan and the Supervisor's Results as mentioned on page 4.**

The Supervisor is invited to give details of any difficulties experienced by particular candidates; giving their names and candidate numbers. These should include reference to:

- (a) difficulties due to faulty apparatus;

- (e) any help given to a candidate.
